

## **Vokèra Vision Plus CASHBACK BONANZA Promotion 2020 Terms and Conditions UK**

### **The promotion runs 1<sup>st</sup> September 2020 – 31<sup>st</sup> December 2020**

These terms and conditions are specific to the Vokèra 'CASHBACK BONANZA' promotion as stated below and are written in-conjunction with the standard terms and conditions which apply for the Vokèra Affinity loyalty and reward scheme.

#### **PARTICIPANTS**

1. The promotion is only open to bona fide registered Gas Safe registered installers who are resident in and are registered to install within the UK (Great Britain & Northern Ireland) and who:
  - a. Are registered members of the Vokèra Affinity support & reward programme:

  - b. Undertake Bona fide standalone installation of an eligible product (see 3 below) during the qualifying period.

#### **QUALIFICATION**

2. Only eligible products purchased from participating merchants located in the UK qualify for this promotion.
3. Eligible products within this promotion are:
  - **Vokèra Vision Plus combi boilers (Models: 25C, 30C, 35C & 40C)**
  - **Vokèra Vision Plus system boilers (Models: 20S, 25S & 30S)**
4. Boilers which receive contract support from Vokèra are not eligible for this offer.
5. Contractors are not eligible to participate in this promotion.
6. All products must be installed during the promotional period 1<sup>st</sup> September 2020 – 31<sup>st</sup> December 2020.

8. All products must be registered through the Vokèra Affinity scheme.
